Subject:- Scheme of Central Assistance for one time settlement of Displaced Families from Pakistan Occupied Jammu and Kashmir (PoJK) and Chhamb under Prime Minister's Development Package- 2015, regarding.

- 1. Whereas, the Government of J&K notified the Scheme approved by the Ministry of Home Affairs, Government of India, for rehabilitation package of PoJK DPs of 1947 and Chhamb DPs of 1965 &1971, in terms of Govt. Order No. 22-DMRR&R of 2017 dated 27.03.2017 followed by Govt. Order No. 07-JK(DMRRR) of 2019 dated 11.12.2019 read with corrigendum dated 11.12.2019, Govt. Order No. 19-JK(DMRRR) of 2020 dated 10.02.2020 and Govt. Order No.20-JK(DMRRR) of 2020 dated 10.02.2020; and
- 2. Whereas, the scheme envisages Rs. 5.5 Lakhs of financial assistance to each family; and
- 3. Whereas, for availing such financial assistance under the scheme, the claimant /head of the DP family or his/her successor or heir settled within the crstwhile State of J&K has to belong to any of the following categories:-
 - (a) Pakistan occupied Jammu & Kashmir 1947 DPs.
 - (b) Chhamb 1965 and 1971 (camp/non-camp) DPs.
 - (c) Those left-out DP families of POJK 1947 who initially opted to move outside the erstwhile State of J&K but later returned and settled back; and
- 4. Whereas, the scheme has been extended from time to time; and latest extension of the scheme was approved vide Govt. order no.31-JK(DMRRR) of 2023 dated 24.05.2023 till 31.03.2024.

Whereas, some families have been left uncovered under the scheme as 5. such, the Government has decided to extend the date for receiving of

applications; and

Whereas, in the minutes of meeting issued by the D/o DMRRR vide No.DMRRR-PoJK/16/2023 dated 22.09.2023 the date for completion of O. application process under Central Assistance Scheme for one time settlement to eligible Displaced families from PoJK 1947 and Chhamb 1965/1971 and WPR be read as 29.02.2024 in place of 31.12.2023 earlier extended to 31.01.2024.

Now, therefore, through the medium of this notice, all the Displaced Persons of PoJK of 1947 & Chhamb 1965 and 1971 (camp/non-camp) 7. DPs, presently settled in the UT of J&K, are hereby notified that in view of the impending closure of the scheme, any eligible beneficiary who has not yet filed his/her claim, may submit the same, in the office of respective Designated Authorities. They may also file such claims in the special camps being organized by the DCs/PRO. No claim shall be entertained

after 29th of February, 2024.
